The annual report states that the SAR services have been delivered to a satisfactory standard.



6. Operational Report & SAR Sector Briefing

Duncan Ferner distributed the operational report and provided an initial overview of the SAR effort for 2019/19 year.

These initial numbers will be refined with additional information in time for the annual report.

7. National SAR Support Programme Briefing

This paper updated the Council on the year-end summary of the 2018 – 2019 National SAR Support Programme, and progress with the 2019 – 2020 National SAR Support Programme.

The secretariat budget of 1.7m for the year was near fully expended, coming in 0.6% under budget (\$11,000)

The NZSAR Council noted:

- the outcomes of the 2018 2019 National SAR Support Programme
- progress on the current 2019 2020 National SAR Support Programme.

8. Volunteer Study briefing and discussion

a. Proposed prioritisation

The volunteer study proposed action table was reviewed by the NZSAR Council this table shows all recommendations along with their proposed actions and priority levels as decided by the NZSAR Secretariat.

Discussion was had regarding the difficulty volunteers are having with the increasing volume of paperwork; the recommendation of e-learning may help this issue.

Mike Shapland (NZDF) stated that framework and structure for administration within training may be extremely beneficial.

SAR Volunteer remuneration and how this could be supported was discussed, the NZSAR Secretariat will engage with officials regarding this issue.

Actions / decisions:

• The NZSAR Council confirmed the proposed 2019 Volunteer Study actions and prioritisation.

9. SAR FED funding discussion

Duncan Ferner provided an overview of the FED business case funding letter that invited agencies to participate in the FED funding review for the period 2020/21 – 2022/23.

a. Principles

The Principles against which the business bases will be judged are as follows:

- Alignment with NZASR Council search and rescue strategy, objectives priorities, letters of intent, risks and risk treatments.
- Changes in the level and nature of search and rescue activity, or other pressures, and their impact on resource requirements.
- Risk, particularly in terms of organisational sustainability.
- Overall funding situation.
- Performance.

Assessment criteria:

- Strategic alignment
- Logic intervention
- Cost understanding
- Implementation / governance

b. Applications

MoT persons present; Johnathan Luo, Karl Simpson, and Helen White

The NZSAR Council reviewed and discussed the mix of FED applications summarised in the spreadsheet. This is to enable officials to group and rank applications.

The council then discussed the most appropriate way to provide collective NZSAR advice to the Ministry of Transport regarding the respective applications.

The Council then discussed, prioritisation, and criteria for NZSAR senior officials to utilize when examining the applications in detail.

The Ministry of Transport investment team require clarity, to ensure Treasury buy-in, as Treasury will question value for money and the appropriate role of government.

Actions:

- Prioritisation of SAR sector goal achievement, and risk mitigation is to be included in the FED Business case application spreadsheet.
- The SAR Senior Officials Group (SOG) are mandated to categorize and prioritise FED funding bids, additional criteria may be included if required. The NZSAR Council may be approached if guidance is required.

10. NZSAR Risk Discussion - SAR Training

The NZSAR Risk Matrix was reviewed by the NZSAR Council.

Each risk treatment was reviewed and discussed in detail.

Actions and decisions:

- Duncan to update risk treatment 2019/03/A on the risk matrix register to reflect the current SAR training funding arrangements
- Duncan to add another column to the risk matrix recognising items not currently in progress.
- The NZSAR Secretariat will monitor treatments ensuring they are being undertaken by SLA partners.
- 2019/03/F The NZSAR Secretariat will confirm the SOG can address incident review recommendations prior to accepting the review report.

11. SAR Training Arrangements - 2019 / 20

This paper updated the NZSAR Council on SAR training arrangements for 2019-2020.

Training is currently being delivered and is tracking well.

A training review is currently underway by the Ministry of Education, this is due to be completed by 2020.

The NZSAR Council Noted:

- The new interim funding arrangements for SAR skill acquisition training arrangements 2019-2020.
- That NZSAR is proposing to apply to the Ministry of Transport's 2019 FED funding process for future SAR training funding.

12. Search and Rescue Legislation

Duncan Ferner and Karl Simpson (MoT) provided the NZSAR Council an overview of the Search and Rescue Legislation Review.

The idea of a hosting department for the NZSAR Secretariat was discussed to help the NZSAR Council complete their responsibilities, moving the NZSAR Council to an executive board.

The NZSAR Council noted / agreed:

- Noted the arrangements for the governance, establishment, and provision of SAR services within the NZSRR is currently provided by four different means; that these arrangements contain two risks; and that the planned introduction of the Civil Aviation and Public Service Bills provides an opportune time to consider the current arrangements.
- Agreed to the transfer of the existing substantive SAR related provisions of the Civil Aviation Act to the Maritime Transport Act 1994, as proposed by the Civil Aviation Bill.
- Agreed that further work should be carried out with the State Services
 Commission to investigate establishing an Interdepartmental Executive Board
 or Interdepartmental Venture for the SAR system when the Public Service Act
 becomes law.

13. SARdonyx

Peter Mersi thanked the NZSAR Secretariat for the successful completion of Project SARdonyx.

Duncan Ferner provided a visual demonstration on the reporting process of the SARdonyx system.

14. Reviews Register

Rhett Emery informed the NZSAR Council that there is an increase in review recommendations.

Action:

• The SOG (Senior Officials Group) are to apply a filter whilst responding to recommendations as to whether they are appropriate for further action.

15. SAR Helicopters

RCCNZ are currently leading SAR Helicopter matters.

A workshop is to be held to discuss how a sector approach would work and how this may affect MNZ and NZ Police.

FENZ are currently investigating an assurance programme that includes fixed wing aircraft.

16. NZ SAR Guidelines

The NZSAR Council confirmed the SOG's approval of the SAR Guidelines for publication.

17. Police SAR Strategic Assessment

Still with NZ Police to be signed off.

18. Projected Defence SAR Capabilities

The Minister of Defence is currently driving awareness capabilities.

RCCNZ are currently engaging with the Ministry of Defence regarding patrol vessels.
